

Leland Man Gets Three-Year Sentence For Cutting Manager

A Leland man who cut a store manager on the throat during a fight in June was sentenced to three years in prison by a Brunswick County District Court judge last week.

Frederick Wayne Ganey, 30, of Route 3, was given a two-year sentence after he pleaded guilty to misdemeanor assault with a deadly weapon. He also received two consecutive six month sentences after pleading guilty to two counts of resisting or obstructing a police officer.

Judge David G. Wall also ordered that Ganey receive substance and alcohol abuse counseling through the N.C. Department of Corrections drug rehabilitation treatment program, DART.

Ganey was also ordered to pay the medical bills of Steven T. Farmer, store manager at Hill's Food Store in Leland, who received a 3 1/2- to 4-inch cut on the throat in the incident that happened June 29.

According to Brunswick County Sheriff's Deputy Steve Mason's report, Ganey attempted to purchase some beer at the store while allegedly intoxicated.

When a clerk refused to sell him the beer, Ganey pulled out a large pocket knife and swung it at Farmer, who was cut on the right side of the throat, Mason reported.
