## BCC Offers Grounds Courses

Brunswick Community College will offer grounds keeping and turf management courses this fall.

For now, the classes will be offered through the Continuing Education Department, but President Michael Reaves said BCC plans to grant students curriculum credit for the classes once the college's planned recreational grounds management technology program is in place.

BCC received \$25,000 from the N.C. Dept. of Community Colleges for startup of the program.

However, a consultant hired to do a feasibility study did not complete

it by the end of the college's fiscal year, said Ann Marie Bellamy, public information officer.

Since one-half of the DCC start-up funds for 1990-91 were to be used to hire an instructor for the program, the college had to revert to the state \$15,500, said Reaves.

Reaves said he expects the recreational grounds management consultant at N.C. State University to send his final report this week. Then BCC will proceed with hiring an instructor/program director.

President Reaves said he will be contacting the local golf course operators to apprise them of BCC's current situation relating to the program.

# County Inspects Food And Lodging Places

Brunswick County environmental health specialists inspected 78 restaurants as well as other food service and lodging facilities during June.

Sanitation grade for restaurants and food or drink stands are based on a system of scoring where an "A" is given to scores of 90 percent or better; a "B" to scores of at least 80 percent and less than 90 percent; and a "C" for a score of at least 70 percent and less than 80 percent. The permit would be revoked for any establishment that receives a score of less than 70 percent.
