BUSES CAN'T BE OVERLOADED

Parents Need To Arrange New After-School Transportation

Tightened state rules mean that yellow buses won't leave Brunswick County school grounds this year if they have even one too many students on board.

Tom Simmons, assistant principal at Union Primary School, said

the change will have the biggest impact at prischools mary such as Union. He said getting children to their proper afterschool destinations will take more cooperation from parents this year.



In past years parents frequently arranged for their child to ride a different bus in the afternoon to a relative's house or to a day care center to stay until they got off work.

And, since more parents bring students to school in the morning than pick them up, buses usually have fuller loads in the afternoons.

Buses sometimes left Union, and perhaps other primary schools, with eight to 10 extra students on board. Most of the "extras" might get off at one of the first stops, a local daycare center, leaving the bus at or below capacity for the balance of the

That won't be allowed this year, said Simmons. Instead, parents need to make other arrangements when students need to go some place other than home after school, such as a day care center, Scout meeting, or a relative's house, that would require riding a bus other than the bus to which they are assigned.

If students board a bus in the afternoon that isn't their assigned bus, it could result in overcrowding and force the driver to leave some students at school until she can return to make a second, late run.

"As much as possible we need to have each child ride one bus," said

Simmons. "If we have a 50-passenger bus, we can't leave the parking

lot with 51 children on it. "If Bus 89 is at capacity and one more child gets on to go to Grandma's, that leaves the bus overloaded. So what do we do?"

However, Simmons said the school staff realizes that emergencies "do pop up" and will try to work with those.

Union Primary is expecting nearly 1,000 students next week, up from a year ago. That, said Simmons, could make the bus situation even tighter, depending on where those new students live.

In an attempt to ease the overcrowding potential, Union Primary has swapped two of its smaller buses for larger buses that weren't running with full loads from West Brunswick High School.

The bus exchange with West Brunswick High School has resulted in a change of buses assigned to two routes. Bus Nos. 7 and 8 have been replaced by Nos. 179 and 182, respectively.

Otherwise, bus routes are essentially unchanged from last year, though a few may be shortened, said Simmons. Only buses serving Shallotte or following N.C. 130 (Holden Beach Road) will travel through Shallotte this year, with others taking the bypass.

"The times for pick-up and dropoff should be about the same," he

In general, buses serving grades K-3 stop at the home of each child. Simmons said. "We're not going to have these kids walking along U.S. 17 to meet a bus. It's different with the middle and high school kids.'

However, while parents might prefer the bus to stop in their driveway, Simmons said state law requires the buses to stop 15 feet in advance of driveways, to allow the driver a better view of the children walking to and from the bus.

County Gets Approval For Flouride Program

Word flowed down from Raleigh Monday that brought a smile to members of the Brunswick County Board of Health.

Plans to flouridate the county's water supply were approved by the N.C. Department of Human Services. The county could have flouridated water as early as October, said County Engineer Robert Tucker.

Tucker had planned to give the health board an update on the county's application, but the letter he received from the state Monday

changed what he had planned to say. 'We'll be going with our public information campaign in October," said Tucker.

the health board has lobbied for a flouride program for two years, asking two boards of commissioners to adopt the program.

The state approved the county's plan to install an estimated \$8,000 to \$10,000 in equipment at the N.C. 211 water plant near Southport. Equipment is already in place at the Northwest Treatment Plant in Malmo.

Public Utilities Director Jerry Webb said the next step is to receive bids for installing the equipment and to file for a state grant to cover the cost.

"We'll contact every customer on the system and doctor offices to make them aware of the flouridation program," said Webb. "That's in case there are any health concerns."

Flouride is thought to work by strengthening the mineral composition of the tooth enamel, making it more resistant to acid attacks, especially for younger chil-

David McDaniel, a dentist who screens children in school, said 36 percent of Brunswick County's students had cavities or severe dental problems when screened in 1989, compared to 13 percent in New

Hanover County.

By Oct. 1, the county may be ready to begin adding flouride to the water supply, Tucker said.
