Bank Claims Marsh Harbour Marina Owes \$1.4 Million

An Illinois-based bank has filed a lawsuit against Marsh Harbour Marina Inc., claiming the Calabash business has defaulted on a \$1.4 million construction loan.

King City Federal Savings Bank, of Mount Vernon, Ill., filed suit Oct. 22 in Brunswick County Superior Court against the marina and Charles E. and Melinda H. Kronenwetter, of North Myrtle Beach, S.C., its operators.

The bank claims it is owed and is asking for \$1,454,221 plus interest on a loan, \$33,402 plus interest for sale of receivables and attorney

As part of the Calabash development, the marina intended to build and sell a time-share project in a condominium building at the marina, the lawsuit states.

Time-shares are joint ownership or rental of a vacation lodging by several persons, with each occupying the premises in turn for short periods each year.

According to the claim, the marina executed a construction loan promissory note worth \$1.5 million on April 24, 1989. The balance plus interest on that note was due and payable on Oct. 23, 1990, it states.

The Kronenwetters, it says, executed a guaranty of payment, guaranteeing the obligations of the marina to the bank note.

The bank has demanded payment for the loan since October 1990, the claim states, but the company has failed and refused to pay the balance due. It says the Kronenwetters have failed "to comply with their obligations" for the loan.

On Aug. 28, 1991, notices were that became delinquent, it claims. mailed to Marsh Harbour and the Kronenwetters, giving them an opportunity to pay the balance without incurring attorney fees, but no payment was made, the lawsuit states.

The amount owed, it states, is \$1,398,000 in principal and \$56,221 in interest, plus attorney fees allowed by law.

Time-shares at the condominium project were to be cash sales or financed sales, in which the purchaser would pay by installments, the claim filed by Wilmington attorney Vaiden P. Kendrick states.

On Jan. 3, 1990, the bank agreed to buy certain receivables or timeshare ownership purchase agreements and installment notes from the marina, provided the marina would agreed to repurchase ones

Five such purchase agreements or notes at the condominium project now in default, worth

\$33,402.69, the lawsuit claims, an

amount that is owed to the bank. As of September 19, 1991, the following amounts were in default, the lawsuit claims: \$8,963.13 for a time-share purchased by R. Steven Baugh; \$5,705.35 for a time-share purchased by Gary W. Martin; \$4,777.06 for a time-share purchased by Edgar C. Simms: \$5,504.77 for a time-share purchased by James L. Paradis; and \$8,011.83 for a time-share pur-

The marina was notified Aug. 26, 1991, that it had to repurchase the delinquent accounts, but has failed to do so, the claim states
