

Two Defendants Get 14-Day Jail Terms After DWI Convictions

Two people convicted last week in Brunswick County District Court on driving while impaired charges must each spend 14 days in the Brunswick County Jail.

Those are among the active sentences handed down in District Court last week by Judge Jerry A. Jolly.

Six defendants either pleaded guilty to or were found guilty of DWI charges before Judge Jolly last week. One defendant was found not guilty.

Another defendant has appealed their DWI conviction to Brunswick County Superior Court.
