

Suspect Pleads Guilty To Taking Drugs From Doctor's Office

A Long Beach man accused of breaking into a local doctor's office to steal drugs pleaded guilty last Thursday, Jan. 9, in Brunswick County District Court to misdemeanor breaking and entering and misdemeanor larceny.

Jimmy Roland Hearn, 38, of 102 N.E. 3rd Street, was charged by Southport Police Officers Lee Smith and Willie Richardson with breaking into the Southport Ear, Nose and Throat Clinic at the Towngate Shopping Center on Dec. 24, the arrest warrant states.

He was given a 14-day active sentence in the Brunswick County Jail.

Hearn was accused of taking 10 boxes of Tagamet, a bottle of Delsyn and a box of Carafate, all valued at \$102, from the building following a break-in at Dr. T. Boyce Cole's office, it states.

On the breaking and entering charge, District Court Judge Napoleon "Poli" Barefoot Jr. sentenced Hearn to two years in prison, suspended for three years and placed him on three years' supervised probation. On the larceny charge, he was sentenced to two years, suspended and placed on probation.

Hearn was also ordered to pay \$200 in restitution to Doshier Memorial Hospital, \$224 to the Southport Police Department, \$250 fine and court costs. He must undergo an assessment, submit to tests and not associate with any previous drug users.

Judge Barefoot also ordered that Hearn not use, possess or consume any illegal drugs. Hearn must also spend 14 days in jail, with work release, to begin at 6 p.m., Jan. 10, the judge ordered.

A charge of unlawful possession of burglary tools was voluntarily dismissed by the District Attorney's office.
