

Four Of Seven DWI Defendants Receive Active Jail Sentences

Brunswick County District Court judges gave active jail sentences to four of seven persons convicted last week of driving while impaired.

Before Judge David G. Wall, two DWI defendants were sentenced. One received an eight-day jail sentence and the other a 24-hour active term.

Five people were also found guilty of DWI charges before Judge Jerry A. Jolly. Three of them received two-year suspended sentences.

Judge Jolly also handed down a seven-day active jail term to one defendant and sentenced another to 24 hours in jail.
