

Stolen Video Tapes Land Leland Man Two-Year Prison Term

A Leland man charged with stealing \$240 worth of video tapes from a Belville business has been sentenced to prison.

Ronnie Lane Potter, 35, of Route 4, Leland, pleaded guilty in Brunswick County District Court March 4 to larceny.

Judge David G. Wall sentenced Potter to two years in prison and recommended that he participate in the DART program, a drug and alcohol rehabilitation treatment program offered to inmates by the State Department of Corrections.

According to the magistrate's order on file at the Brunswick County Clerk of Court's office, Potter was charged Jan. 13 for the Jan. 11 incident. It accused him of taking 18 video tapes and video cassette head cleaners from the Hollywood Video store on N.C. 133 at Belville.

Brunswick County Sheriff's Deputy William Hewett reported that the defendant entered the store around 7:20 p.m. When a clerk became distracted by other customers, the defendant grabbed 18 videos from a shelf and ran out the front door, Hewett stated.

Video tapes worth \$200 were taken along with \$40 in cleaning tapes, Hewett stated. Charges were filed following an investigation by Brunswick County Sheriff's Detective Ken Messer.
