

# Sunset Teen-Ager Has Two-Year Suspended Sentence Activated

A Sunset Beach teen-ager charged in a 1990 fatal wreck was back in Brunswick County District Court last week.

Matthew Shawn Arnette, 18, had a two-year suspended sentence activated following a motion hearing in court last Thursday, March 26.

The sentence stems from a Nov. 3, 1990, driving while license revoked charge filed by State Trooper B.D. Barnhardt, according to documents on file at the Brunswick County Clerk of Court's office.

District Court Judge Jerry A. Jolly ordered that Arnette's two-year suspended sentence from that case be activated and also ordered that he receive counseling for substance and mental disorders through the N.C. Department of Corrections' DART program, a drug and alcohol rehabilitation treatment program.

Arnette pleaded guilty to death by vehicle on Aug. 27, 1990, stemming from an accident that claimed the life of a Supply man.

Clyde Justice Olive, 37, died from injuries after the car Arnette was driving ran a stop sign and struck Olive's car on Sabbath Home Road near Holden Beach on March 18, 1990.

From that charge, Arnette was given a two-year suspended sentence and placed on two years' supervised probation by Judge Jolly.
