

Five Sentenced In Brunswick Court For Fisheries Violations

Several people appeared in Brunswick County District Court last week on charges filed by N.C. Marine Fisheries officers.

Charges include robbing crab pots, taking more than 100 clams without a license, possessing oysters during closed season, taking oysters from polluted waters and commercial fishing without a license.

Judge David G. Wall handed down fines in most cases ranging from \$25 to \$10 plus court costs and suspended sentences.
