## Robber Flees Leland Restaurant With Cash Sunday Afternoon

Detectives believe a man who robbed the Sandpiper Seafood House restaurant in Leland Sunday had robbed a Wilmington convenience store earlier in the day.

The man entered the restaurant on Village Road around 3:21 p.m. and asked to use the restroom, said Brunswick County Sheriff's Detective Gene Caison.

He returned from the restroom two minutes later, gave the cashier a plastic bag and told her to fill it with \$10s and \$5s, said Caison. He left with an undetermined amount of money.

"We're thinking it's possibly the same guy," said Caison. "He never showed a weapon. He just placed his hand up under his left armpit like he

He is described as 20 to 25 years old, approximately 6 feet tall, weighing from 200 to 210 pounds, with a light complexion, short black hair and a large nose. He was wearing a red flannel shirt over a second shirt and dark pants.

The suspect in the Wilmington robbery was also wearing glasses, a baseball cap and work boots.

Restaurant employees said the robber fled on foot toward Old Fayetteville Road.
