

Man Gets Six-Month Sentence For Injuring Property

A Longwood man who pleaded guilty to injuring personal property was sentenced to a prison term of six months in Brunswick County District Court Thursday.

Traffic cases made up the major portion of the docket in three days of court. Judge Napoleon B. Barefoot presided over the proceedings Tuesday and Wednesday, while David G. Wall heard cases Thursday. Assistant District Attorney Ola Lewis prosecuted cases for the state.

Eddie Durbett Allen, no operators license, owning and operating vehicle with no insurance, consolidated judgment, Brunswick County Jail 60 days, suspended sentence two years, \$15 and costs, no operate motor vehicle until valid license, no operate motor vehicle unless properly insured.
