Hewett A Semifinalist At N.C. Science And Mathematics School

Perty Hewett, a former student at West Brunswick High School, is one of 19 students at the N.C. School of Science and Mathematics named semifinalists in the 1993 National Achievement Scholarship Program for Outstanding Negro Students.

They will compete in the National Merit Scholarship program for about 700 scholarships worth about \$3 million to be awarded next spring for college undergraduate study.

Semifinalists nationwide were selected from more than 80,000 black students who requested consideration by taking the PSAT and National Merit Scholarship Qualifying Test in 1991.

Finalists will be selected on the basis of academic records, recommendations, scholastic and extracurricular accomplishments and goals and confirmation of their qualifying performance on a second test.

Altizer Cited
