Power Tools Reported **Stolen From Ocean** Isle Hardware Store

More than \$600 worth of power tools and equipment was stolen from the True Value Hardware store in Ocean Isle Beach last week, according to a crime report of file at the Brunswick County Sheriff's Department Monday.

The owner told deputy Robert Long II that someone apparently came into the store during business hours and stole three electric drills, an electric drywall screwdriver, a reciprocating saw and a battery.

The theft is believed to have occurred sometime between 8 a.m. Wednesday (Feb. 10) and 10:30 a.m. Thursday.

In other crime reports at the sheriff's department Monday:

A riding lawn mower, a garden tiller and a chain saw CRIME valued at a total of \$1,800 were stolen from a home on N.C. 130, REPORT Supply, last week. The homeowner told investi-

gating Deputy J.D. Davis that the tools were stored under a roof overhang next to his barn. He said he last saw them there Thursday afternoon and discovered the items missing Friday afternoon. There was no sign of forced entry into the barn, Davis's report said.

Someone broke into a home on Magnolia Road, Seaside, and stole about \$1,200 worth of stereo equipment and other items recently.
