

Former Student Gets 10 Days For Bringing Pistol To School

A former student at West Brunswick High School was sentenced to 10 days in jail and put on two years probation last week after admitting that he brought a .380-caliber pistol onto school grounds last November.

Marc Anthony Dubose, 19, of Ocean Highway, Shallotte, pleaded guilty in Brunswick County District Court Tuesday to one count of possessing a weapon on campus.

Dubose was a student at West Brunswick High School when he was arrested by sheriff's Deputy Sheldon Caison Nov. 29. School records indicate that Dubose withdrew from the school the following day.

In addition to his active jail term, Dubose was also sentenced to two years in prison, suspended on the condition that he pay \$200 for his court-appointed lawyer and \$60 in court costs. He was ordered not to go on the campus of any public schools in Brunswick County without permission and to not violate any laws for two years.

Judge Jerry Jolly further ordered that the pistol be destroyed by the sheriff's department.

Jolly presided over three days of district court last week. Assistant District Attorney Rick Green prosecuted cases for the state, while Marie Jordan served as courtroom clerk.

Other defendants who appeared in court last week, with their charges, pleas and judgments include:
