

Man Cited For 'Obscene Gesture' Found Guilty Of Assault With Truck

A 39-year-old Belville man, recently cited for allegedly making obscene gestures in court, was found guilty last week of assault with a deadly weapon for trying to run over a Leland man with a truck.

Larry Weber of Main Street was sentenced to two years in prison, suspended on the condition that he perform 48 hours of community service, pay \$60 court costs and write a letter of apology to the man he tried to run over.

The case was originally scheduled to be heard May 23, when District Court Judge Jerry Jolly found Weber in contempt of court because he "on at least three occasions made an obscene gesture with his middle finger, commonly known as 'The Bird,' toward Chief (Charles) Cliff of the Leland Police Department." The judge ordered Weber thrown in jail for seven days.

Weber has appealed both decisions to superior court.

Judge Ola Lewis presided over three days of district court in Bolivia last week. Assistant District Attorney Marion Warren prosecuted, while Marie Jordan served as courtroom clerk.
