The book is available for less than seven dollars at most booksellers.

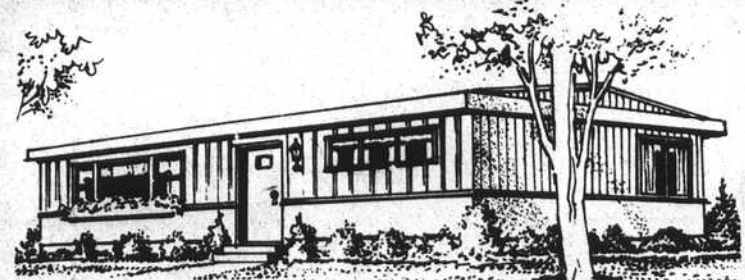
