The meeting of the Pamlico County Firemen's Association originally scheduled for Thursday, April 18, has been rescheduled for Thursday, April 25. It will be held at Triangle VFD and will start at 7:30 pm.

Rescue

At one time, Beeman explained, the rescue squad asked doctors in New Bern to call and request squad transport for patients who couldn't be moved in other ways. Perhaps the squad could require a written referral from a patient's physician before transporting, he said.

Beeman emphasized that the rescue squad had no complaints about transporting a patient who could really travel no other way and that most of these patients provided adequate advance notice. But Beeman recounted one call. "It came in as an emergency," he said. Beeman said he went on the call and when he arrived, it wasn't an emergency. "They said they didn't want grandpa to get wet." Grandpa was waiting at the door, packed, and the family followed the squad to the hospital. Other squad members can recall similar situations.

The rescue squad is also called upon to transport women in labor, Beeman said. This is not normally an emergency situation, he explained, since most expectant mothers have more than enough time to reach the hospital once labor begins--"and they've had nine months to prepare." It is usually known beforehand if the pregnancy will be a problem, he added, and arrangements can be made early for those situations. There have even been times in the early morning hours when the squad has been asked to transport a woman in labor because the family car didn't have enough gas and there were no stations open. A little advance planning would have been the solution, he commented.

The squad is also called upon to transport patients to Duke Hospital or to the VA hospital, said Beeman. If it's just for tests, the volunteers end up waiting, sometimes for several hours. Beeman added that he understands that both Duke and the VA have contracted ambulance services that can provide transport recommended by the physician.

Beeman said that he did not want anyone to hesitate calling for a medical emergency but that the squad could not provide a "taxi service." Some of the patients just need assistance getting to the car, he said. If friends or relatives aren't available and the rescue squad is called, the volunteer could go to the residence to assist, without being tied up for several hours waiting, if told this at the time the request is made.
