

# **Timely Questions On Farm Answered**

Question: How often should dairy animals be watered during the winter months?

Answer: Cows in milk should have access to a plentiful supply of water at least twice a day. A cow in milk will consume from ten to thirty gallons of water a day and cannot drink enough at one time for the natural requirement. Water is also the cheapest of all feeds and will pay big dividends in increased production. If warm, fresh water is kept before the cow, she will consume more and her production will be increased.

Question: Will it pay to buy an incubator to hatch eggs from a flock of 50 laying hens?


