Certificate Of Birth Given To Governor

Governor John Christopher Blucher Ehringhaus, of North Carolina was presented Tuesday with a certificate of his birth more than half a century ago by Dr. Carl V. Reynolds, acting State health officer and secretary of the State Board of Health.

Dr. Reynolds related briefly the achievements of Burbank with plant: and of biologists in producing speci mens approaching prefection. He congratulated Governor Ehringhaus or his parents and the excellent speciman of manhood they produced in him a he presented the little copy of the Governor's "citizenship papers."
"I thank you, Dr. Reynolds, and ap

preciate this evidence that I was born," said Governor Ehringhaus "Your campaign should have the hearty and full cooperation of the citizens of the State. Children now will live to appreciate the care their parents exercise now in making sure that their births are registered. appreciate mine."

Governor Ehringhaus, the certificate he proudly displayed, shows, was born in Elizabeth City, N. C., February 5, 1882, the son of Erskine and Carrie Colville (Mathews) Ehringbaus. His father was 28 and his mother 25 years old when he was born. He was born "without benefit of bookkeeping," as births were not required by law to be registered until 1914. His mother had died, as had the attending physician, Dr. W. L.

Only his father, Erskine Ehringhaus, now approaching his 82nd birth sary, is living, of those whose s to the birth would be accentout question. The father has ick, but was again about his duties a few days ago. Certainly within a few years, at most, the father would not have been here to make out a certificate of birth for the Governor of North Carolina-and much trouble would have been experienced to establish that fact.

The certificate was presented as feature of the "Register Your Baby" campaign now about to end in North Carolina, conducted by the Bureau of the Census, State Board of Health and State ERA.

Most Small Grain **Needs Top-Dressing**

Seven out of every ten of the 800. 000 acres of small grain now growing in North Carolina will benefit from a p dressing of quickly available

"On this basis, there are at least 0,000 acres of small grain that should be top-dressed this spring." says W. H. Rankin, agronomist in soil fertility at the North Carolina Experiment Station. "Our studies show that the average yield of wheat per acre in North Carolina for 1934 was only 10 bushels. The average yield of oats was 17 bushels; of rye, 7.5 bushels, and of barley, 17 bushels These are low acre yields and should be improved. They may be increased by the application of such quick-act ing nitrogen fertilizer as nitrate of soda or sulphate of ammonia. The usual application is 75 to 100 pounds

Rankin points out that the addition of 20 pounds of nitrogen in the form of a top-dresser will cost about \$1.50 per acre. It will require 1 1-2 bushels of wheat to pay for this nitrogen and it is not unusual fer an application of 100 pounds of nitrate of soda, or its equivalent, to increase the acre yield from 25 to 50 percent.

Apply the top dressing material af-ter freezing weather is over and the grain begins to make spring growth While too early an application may hurt the grain should growth be stimulated and late frosts occur, still most nitrogen top-dressings are applied too late to be of most benefit.
