Skinner Withdraws as **Candidate For Rep**resentative

There is nothing very exciting in the local political situation, with the only two contests being for the office of Representative, and for that of Recorder's Court Judge.


A. Linwood Skinner's withdrawal from the race before it had begun. leaves only two contestants for the office of Representative, J. T. Benton, who represented the county at the last General Assembly, and W. T. Brown, who formerly held the office for several terms. Mr. Brown, who lost in his fight for a seat in the Senate two years ago, served as sergeant-at-arms in the General Assembly.

There are three candidates for the office of Recorder's Court Judge, Hon. James S. McNider, who is serving the unexpired term of Walter H. 
