LEND AN EAR—AND PEP UP
Do you feel "all in", worried and despondent over conditions in general? Are you just about ready to give up and let everything drop where it is?

All of us feel down-in-the-mouth now and then, and right now anyone will admit that things are not as rosy as they have been, and if you are wildly wondering where your next bank balance is coming from, The Weekly begs you to read the next few paragraphs before you dust off the old shotgun and end it all.

"It is a gloomy moment in history. Not for many years—not in the lifetime of most men who read this—has there been such grave and deep apprehension, never has the future seemed so incalculable as at this time. In our own country, there is universal commercial prostration and panic, and thousands of our poorest fellow-citizens are turned out against the approaching winter without employment, and without the prospect of it.

"In France the political cauldron seethes and bubbles with uncertainty, Russia hangs as usual like a cloud, dark and silent, upon the horizon of Europe, while all the sources and influences of the British Empire are now sorely tried, and are yet to be tried more sorely, in coping with the deadly disturbed relations in China.

"It is a solemn moment, and no man can feel indifference—which, happily, no man pretends to feel—in the issue of events.

"Of our own troubles (in the U. S. A.) no man can see the end. They are, fortunately, as yet mainly commercial, and if we are only to lose money, and if painful poverty to be taught wisdom—the wisdom of honor, of faith, of sympathy, and of charity—no man need seriously despair. And yet the very haste to be rich, which is the occasion of this widespread calamity, has also tended to destroy the moral forces with which we are to resist and subdue the calamity."

A dark picture, isn't it? Perfectly descriptive of our times, The Weekly thinks. A hopeless outlook, but wait a moment—the quoted paragraphs you just read are EIGHTY-ONE YEARS OLD. They appeared in Harper's Weekly, October 10, 1857.

So, herein, we see there's nothing new about the "jitters." We have had them before and will have them again, and knowing that our fear is not original is one of the best ways to get rid of it.

At least one business in Hertford must have weathered the storm of 1857, since this business was established more than a century ago. So, since there is nothing new about "recessions", let's forget the jitters and put the best efforts in our work, whatever it may be.

The Mount Clemens (Michigan) Daily Leader is to be congratulated for first putting a real wallop into this "anti-recession" idea.
