

Peanut Growers Warned Of Treatment

Peanut growers of Perquimans County were advised this week by I. C. Yagel, County Agent, of action taken at a meeting of the Virginia-Carolina Peanut Association, held in Suffolk, Va., on May 5.

According to Mr. Yagel the Association reported that extensive research had revealed that the use of Benzene Hexachloride and Lindane has proven harmful to peanut crops and land, and the Association passed a resolution urging peanut growers to forego the use of these items in treatment of peanuts.

The Association is opposed to the use of the items and is asking all producers to cooperate, for benefit of all, not to use either of these items. Both, it is reported carries to the peanuts an obnoxious odor and taste.


