**Home News**

Many people think of brown as a predominant color in dried flower arrangements, but you can have yellows, greens, reds, blacks and whites. Wild flowers, grasses, berries and seed pods may also be used. It is time to begin saving materials in order to have attractive arrangements next Fall. Gather flowers and strip off all the leaves. Bunch them together without letting the heads touch and hang upside down in a dark, dry place. The time required for drying varies from a few days to several weeks. Flowers may also be dried by the borax method. After the leaves are arranged the flowers are placed upside down in enough borax to cover them. Be careful not to let the flower heads touch each other. Look at these flowers every two or three days and when they are dry remove from the borax, brush with a slightly dampened brush and hang upside down for a day or two.

Leaves help to make attractive arrangements and ferns and small leaves may be pressed. Leaves may also be preserved with a mixture of one-third glycerin and two-thirds water. Submerge the leaves in the mixture until they have absorbed the glycerin. This takes two or more weeks. They should be wiped carefully and allowed to stand in a well-ventilated place before storing.

By the use of these three methods you may have a variety of colors and texture in your arrangements. Gathering flowers a few days apart will help to give you variety. Be very sure that the leaves are removed and that the dried flowers are stored in a safe place until they are to be used.

March is "Cottage Cheese Promotion Month." Cottage cheese is a good food and not just something to make a salad look good. One of the foods most lacking in the diet is milk and since cottage cheese is a concentrated form of milk, it is one good way to get nutrients in milk in the diet in a substantial amount. Cottage cheese is easily digested and it is a wonderful food for those who wish to lose weight because it is low in calories. It is also one of the most versatile foods; therefore, the family need not tire of it.

For a lunch salad, cottage cheese combines nicely with almost any type of food. A few examples are:

Applesauce Cottage Cheese Salad: 1 pk. lime-flavored gelatin, 1 cup water, 2 cups unseasoned applesauce, 1 cup cottage cheese. Dissolve lime gelatin in water. Fold in applesauce and cottage cheese, and pour into individual molds. Put in refrigerator until firm. Unmold on lettuce and serve with mayonnaise.

Cheese Stuffed Peppers: 6 green peppers, 1 1/2 cups cottage cheese, 2 1/2 cups cooked rice, 1 egg, salt and pepper, buttered soft bread crumbs. Wash peppers, cut off tops and remove stems, seeds and white fibre. Cook peppers and the tops in boiling salted water for about 10 minutes. Drain. Mix the cottage cheese, rice, slightly beaten egg, salt and pepper to taste and the pepper tops chopped coarsely. Fill the peppers with this mixture. Top with the buttered bread crumbs and place in a buttered baking pan. Bake in a moderately hot oven (375 degrees F.) for about 25 minutes. Six servings.
