

County Commissioners are seek ing public reaction to a request Perquimans County relinquish its claim on the Medical Care Com-

mission to assist in a proposed plan for construction of a new_hospital in Pasquotank County. The quest was presented to the

local board at its meeting on April 1. and the Commissioners took the proposal under advisement until its meeting on May 6.

Pasquotank authorities pointed out the need for a larger, modern hospital in their county aimed at serving a five county district in this immediate area. In order to finance a project this large, the Pasquotank officials pointed out, extra funds, available through the Medical Care Commission, will be needed in order to assure construction of the new building.

Counties seeking new hospitals are allocated aid from federal and state sources from time to time and it is this assistance the Pasquotank authorities are requesting rom Perquimans, Camden, Currituck and Dare to permit them to construct a hospital of the size required for the needs of the district. It was pointed out to the local Board surrendering this county's claim for funds will not affort fu-


