It is estimated that 85% of the peanuts harvested in the county in 1963 were dried artificially.

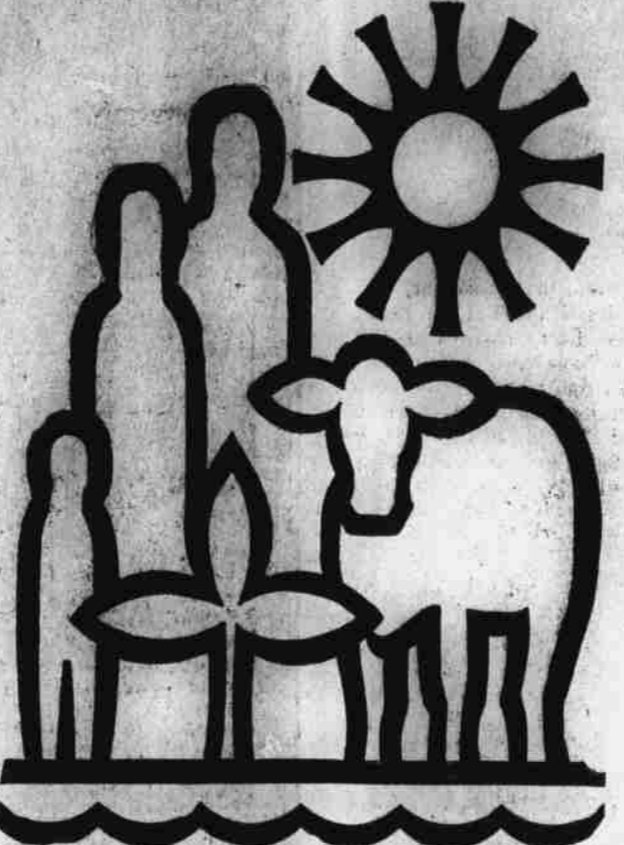
