In addition to all	other penalties prescribed by law, any person whose duty	it is to

In addition to all other penalties prescribed by law, any person whose duty it is to list any property who wilfully fails or refuses to list the same within the time prescribed by law shall be guilty of a misdemeanor punishable by a fine not to exceed five hundred dollars (\$500.00) or imprisonment not to exceed six months. The failure to list shall be prime facts evidence that the failure was wilful.

Any person who removes or conceals property for the purpose of evading taxation or who aids or abets the removal or concealment of property for the purpose of evading taxation shall be guilty of a misdemeanor punishable by a fine not to exceed five immidred dollars (\$500.00) or imprisonment not to exceed six months.
