"BOND ORDER
AUTHORIZING THE
ISSUANCE OF \$25,000
SANITARY LANDFILL
BONDS OF THE COUNTY OF
PERQUITMANS"

WHEREAS, the Board of Commissioners of the County of Perquimans deems it advisable that sanitary landfill facilities for the disposal of garbage, refuse and other wastes be maintained and operated by said County jointly with Chowan County and it will be necessary in connection with such joint facilities to acquire vehicles, equipment, apparatus and furnishings for use in conjunction with such facilities and said Board of Commissioners desires to provide for the

financing of part of the cost thereof; NOW, THEREFORE, BE IT ORDERED by the Board of Commissioners of the County of Perquimans, as follows:

Section 1. The Board of Commissioners of the County of Perquimans has ascertained and hereby determines that, in order to provide vehicles, equipment, apparatus and furnishings to be used in conjunction with the Sanitary Landfill Facilities maintained and operated by the County jointly with Chowan County, it will be necessary to make the improvements hereinafter described and that it will be necessary to provide for such purpose not more than \$26,000 from the proceeds of bonds, in addition to any funds which may be contributed by the Federal Government or any of its agencies, or which may be provided by the County or State or from any other source.

Section 2. In order to raise the money required to finance the acquisition of vehicles, equipment, apparatus and furnishings to be used by the County jointly with the County of Chowan in conjunction with the maintenance and operation by said Counties of joint Sanitary Landfill Facilities for the disposal of garbage, refuse and other wastes, bonds of the County of Perquimans are hereby authorized and shall be issued pursuant to The County Finance Act of North Carolina. The maximum aggregate
