NOTICE is hereby given of intention of the undersigned to file application with the Local Government Commission, Raleigh, North Carolina for its approval of the issuance of bonds of the County of Perquimans, which bonds shall be subject to approval of the voters of said County at an election and shall be for the following maximum amount:
