Machinery Act of 1971 , GS. 105-308, Duty to list; penalty for fallure.
Every person in whose name any property is to be listed under the terms of this sub-chapter shall list the property with the tax supervisor or proper list taker within the time allowed by law on an abstract setting forth the information required by this sub-chapter.
In addition to all other pencities prescribed by law, any person whose duty it is to list any property who willfully fails or retuses to list the same within the time prescribod by law
shall be guilty of a miscemeanor punishable by a fine not to shall be guilty of a misclemeanor punishable by a fine not to exceed six months. The fallure to list shall be prima facie evidence that the fallure was willful.
Any person who removes or concecls property for the purpose of evading taxation or who aldes or abets the removfaxation shall be gullity of a misdemeanor punlshable by a fine not to exceed tive hundred dollars (\$500.00) or imprisonment not to exceed six months.
