Bridge to be named

HERTFORD-Acting on a request by Representative Vernon James, the Perquimans County Board of Commissioners voted Monday to present a resolution to the North Carolina Department of Transportation to name the bridge that crosses the Perquimans River on U.S. 17 By-Pass in honor of the late Joseph Warren Nowell, Jr.

The span, which links Hertford and Winfall, has been in use for approximately 20 years.

The request will ask that it be named the Joseph W. Nowell, Jr.

Prior to his death in 1985, Nowell had served as a member of the Perquimans County Commissioners, and was former Highway Commissioner.

A motion to present the resolution to the D.O.T. received unanimous approval of the board.
