

Perry elected

NAGS HEAD—The First Congressional District Republican Party, meeting in convention at the Outer Banks Coliseum Saturday re-elected District Chairman Steven P. Rader to a second 2-year term.

Rader, 34, is a Washington, N.C. attorney and past chairman of the Beaufort County Republican Party. He defeated Dan Lawrence of Frisco, Treasurer of the Dare County Republican Party, by vote of 412 to 16. Lawrence then asked that his name be withdrawn and the election of Rader be declared unanimous.

The 1st district is composed of 21 counties in northeastern North Carolina.

Elected as district vice chairman was Shirley E. Perry of Route 2, Hertford, N.C. Mrs. Perry is past president of the Perquimans County Chamber of Commerce and was the Republican nominee for the N.C. House of Representatives in the 1st State House District in 1986.
