Handle medical waste carefully for safe disposal

Most medical waste generated in the home can be easily and safely managed by the caregiver. According to the Environmental Protection Agency (EPA) you can prevent injury, illness, and pollution by following some simple steps when you dispose of sharp objects and contaminated materials you use in taking care of someone in your home.

Needles, syringes, lancets, and other sharp objects should be placed in a hard plastic or metal container with a screw-on or tightly secured lid. Tape the lid if necessary to make sure it stays on. Do not use glass or clear plastic containers, and label the container "do not recycle." This container may then be disposed of in the household

The EPA also recommends that soiled bandages, disposable sheets, and medical gloves be placed in securely fastened plastic bags before you put them in the garbage can with your other household trash.Double bagging these items may be wise.
