Man dies after a fight with trooper

Both the State Bureau of Investigation (SBI) and the North Carolina Highway Patrol are looking into the death of a Woodville man who died last week after fighting with a state trooper during which the officer's Taser was used several times.

Sgt. Jeff Gordon with the Highway Patrol said Clayton Earl James, of 1138 Woodville Road, was pronounced dead at Albemarle Hospital following the 10:30 p.m. chain of events that started Thursday night in Pasquotank County and ended in Perquimans.

The Highway Patrol is conducting an internal investigation into the matter while the SBI probes incident at the request of both the Highway Patrol and District Attorney Frank Parrish. Following agency protocol, Trooper W.A. Hardison has been placed on administrative leave pending the outcome of the investigation.

According to Gordon, Trooper Hardison tried to stop James' vehicle on Old U.S. Highway 17 in Pasquotank County about 10:30 p.m. Dec. 2 after seeing the vehicle cross the center line several times. Hardison finally stopped James' vehicle on Nursing Home Road just over the county line in Perquimans on suspicion of impaired driving.

The law enforcement officer asked James to get out of the vehicle, then told the driver to take his hands out of his pockets after exiting the vehicle, but James would not follow commands, Gordon said.

When Hardison attempted to place James under arrest, a fight broke
