Due to recent rains and hurricane Matthew, Albemarle Utility Company (AUC) has experienced increased water levels in its storage lagoon. The increased water levels have caused seepage in the lagoon containment berm. In order to minimize the seepage and return the water levels to permitted levels, and allow repairs, the State of North Carolina

Department of Environmental Quality (NCDEQ) has authorized AUC to spray effluent on its approved spray fields beyond normal operational limit. The increased level of spraying of treated effluent will create runoff of approximately 15,000 gallons. The effluent runoff has been disinfected with chlorine. Most all of the runoff will be contained on property owned by AUC but you should be aware that any contact with water near the AUC spray fields may be sewer effluent. All activities and operations during this emergency are being performed with the coordination and cooperation of the NCDEQ.
