mission building. The board opted to take \$500,000 out of its reserve fund and borrow the remaining \$2.5 million to pay for it.

Neither library projects were moving forward at the time of Ward's death and since that time COA pulled the plug on its athletic program completely. Perquimans County also failed to raise the money needed to start building a new athletic complex on donated land across from the high school.

But at the time before his death, Ward chaired a committee formed to raise funds for the Perguimans project.

The original land offer in 2010 from Dr. William Nixon was he would give the land to the school system if it built an athletic complex in five years. That didn't happen, and Nixon has since extended the offer.

sion indefinite, but left the door open to changing that if funding was available.

For now the COA board has tabled a decision on what to do until their next meeting.

At the time trustees suspended athletics the second time, the college was spending approximately \$90,000 a year on the program. College officials said the program needed more money, however, to field another women's team to comply with federal anti-discrimination rules


