Eugene Rountree, Sr. Scholarship — This \$500 scholarship in memory of Eugene Rountree, Sr. is sponsored by the Inter-County Department Fire Department and is available to a high school student. Hertford, DOT opted to go with the design-build meth-


Under design-build, the contractors will submit the estimated cost to build the project along with projections for how long it will take. Because DOT and county and town officials are concerned about delays, a bidder may be selected even if they bid a higher dollar amount if they can show how they can complete the project faster.

Under original estimates, the closure between Hertford and Winfall could be two to three years.


