## **Taxpayers Ask IRS**

This column of questions and answers on federal tax matters is provided by the local office of the U.S. Internal Revenue Service and is published as a public service to taxpayers. The column answers questions most frequently asked by taxpayers.

A bave filed, you should then file a form 1040X, Amended U.S. Individual Income Tax Return. On the form 1040X, you can recompute the portion that has changed and send it, with any necessary related information, to the address shown in the instructions for that form.

Q. Both my wife and I became 65 years old in 1975. I understand that because of our age, we get some special tax benefits. What are they?

A. Persons age 65 and over have special filing requirements. Single persons in this age group do not have to file an income tax return unless they earn a gross income of at least \$3,100 (compared to \$2,350 for taxpayers under 65). Married persons filing der 65). Married persons filing jointly and living together at the end of the tax year do not have to file unless income is \$4,150 or more if one of them is at least 65, and \$4, 900 if both are in this age group.

Also, persons 65 and older are Also, persons 65 and older are allowed an additional \$750 exemption for their age, in addition to the normal \$750 personal exemption. There are several other tax benefits for persons at least 65. For a complete explanation see IRS Publication 554, Tax benefits for Older Americans, available at most IRS offices.


