#### Aggies and Eagles Stage Point Blitz; Deadlock, 28-28 Before 19,000 Fans

Bowl-bound North Carolina Central battled back from a 22point deficit in the fourth quarter to deadlock North Carolina A&T, 28-28 before 19,000 fans last Saturday.

Sparked by their fancy dan quarterback Herman Matthews and speedy end Julian Martin, the Eagles punched across three touchdowns within a nine-minute period in the final quarter. They clinched a tie with 4:41 left in the game when Martin grabbed Matthews' pass for a two-point PAT.

The Aggies, trying to gain the Central Intercollegiate Athetic Association (CIAA) championship, threatened the run away with NCC before the Eagles staged their fourth quarter blitz.

With senior quarterback Stan Jacobs at the helm, A&T struck paydirt the first play they run. Jacobs hit end Willie Wright with a 20-yard scoring toss with just 31 seconds expired.

Three minutes later, Jacobs sneaked one-yard for another (Continued on Page 8)
