Q - I have a service-connectorate the Fellowship Hall for ed disability which recently be-Easter Sunday. Bring your came worse, necessitating the amputation of my right leg. Would I now be eligible for the \$1,600 payment toward purchase of an especially adapted automobile from VA?

> A - Yes, providing your service-connected disability was incurred or aggravated during World War II or the Korean Conflict. You may also be entitled if your disability is related to service after Jan. 31, 1955, and was incurred as a direct result of the performance of active duty.

Q - What is the Modified Life Plan which is available to holders of National Service Life Insurance policies?

A - This is a plan of insurance providing a lifetime level premium that is lower than permanent plans. It avoids the periodic premium increases of term insurance. The face amount is reduced to one-half at age 65 when insurance needs usually decline. It must be applied for before the veteran reaches insurance age 61, which is six months after his 60th birthday. Q - How many semester hours are required for full time

training in graduate school? A - An accredited graduate course will be considered full time when 14 semester hours or the equivalent are taken unless it is the established policy of the school to consider less than 14 hours or the equivalent as full time enrollment. A school official must so certify.

Q — I have a G.I. loan on my home. I want to borrow money on my equity in the home for my children's college education. Is it necessary to obtain the approval of the Veterans Administration for such a loan?

A - No. However, a G.I. loan cannot be obtained for this purpose.

Q - My brother received an honorable discharge from his Korean Conflict service. He later received a bad conduct discharge from his Post-Korean service. Does this bar him from all veteran benefits?

A - No. Benefit entitlement earned during your brother's honorable wartime service is undistrubed by his subsequent Post-Korean service provided there was a break between the two service periods.

As far as the bad conduct discharge 'is concerned, the Veterans Administration will determine, after a review of the facts, whether the discharge was under conditions which would preclude benefit entitlement.

Q - Does the Government pay a medal of honor winner anything for winning this honor?

A - Yes. He receives \$100 a nonth for this upon application.

Q - I was recently separated from the Army after having served four years. I got my high school diploma while I was on active duty. I wanted to start college this fall but the school I applied to would not accept. Me. Can the VA exert any pressure so that I can be accepted?

A - We are sorry, but the VA cannot influence the officials of any school as to their acceptance or nonacceptance of a student.

More than one and a third million Americans and one million of their dependents have learned they can count on Social Security - not just when they retire, but to help see them through misfortune NOW. They have one thing in common: serious sickness or accident has caused them untold hardship. Some are ex-servicemen whose wounds disabled them. Some are workers who never missed a day of work until sickness or accident struck them down. Some are children whose father or mother suddenly became disabled. Each receives a monthly disability check from Social Security.

In emphasizing the disability provisions of social security today, Charles H. Myers, Greensboro District Social Security Manager said: "When Social Security began nearly 35 years ago it was only a program for retirement. But now it's a lot more than that. It has been improved to cover more and more instances of unforseen catastrophe which strike the young as well as the old. Disability is just one of these instances. When you

are talking about social security, you're talking about something to be counted on NOW. And when you're thinking about lifetime protection, you're thinking about social security."

Myers urged individuals who have questions about various parts of the Social Security program to contact the Social Security office to get proper and timely information. Asking a friend or neighbor who is a beneficiary for information about Social Security is not always wise because the facts in each case are not necessarily the same. The people in the Social Security office at 324 W. Market St. will be glad to be of assistance.



**Mulch Keeps Soil** 

**Temperatures Down** "Mulch" is a 2 to 3-inch lay-er of material such as peat er of material such as peat moss, sawdust or other organic matter. In some areas, ground corn cobs, buckwheat hulls, or cocca bean shells are used. Straw is widely applied in the fall as a through the winter mulch. The use of bark chunks is becoming more widespread, as hear in order bark chunks

is becoming more widespread, as bark is not only beneficial as a mulch, it's decorative as well. well. A good mulch benefits the soil in a number of ways. It conserves moisture by slowing evaporation of water; it eases cultivation by suppressing the growth of weeds; it prevents the "crusting" of soil, helping water penetrate into the root sone; and it insulates against the hot summer sun. Soil tem-peratures under a 2-inch mulch

peratures under a 2-inch mulch will be 6 to 8 degrees lower than soil without mulch, thus eliminating root-killing high temperatures at the surface.



Garden Bark, a bark mulch made by the Weyerhaeuser made by the Weyerhaeuser Company, comes in two grades. Regular, with chunks 1/4" to 1" in size is the most popular for everyday usage around trees and shrubs, in flower beds and along borders, and Extra Coarse with chunks 1" to 3" in size adds an attractive "tex-tured" effect to your garden.
