## Veterans' Corner

Editor's Note: Below are authoritative answers by the Veterans Administration to some of the many current questions from former servicemen and their families. Further information on veterans benefits may be obtained at any VA office.

**Q** — I attend school under the G.I. Bill, and my wife has given birth to a son. How do I notify VA of this additional dependent?

**A** — Forward immediately to your VA regional office a copy of the child's birth certificate. Write your VA file number on the document and attach a note stating that you are training under the G.I. Bill.

**Q** — I am a reservist and have been on active duty for the past six months. Will my Servicemen's Group Life Insurance protect me during the 120-day period immediately following separation from six-months' military obligation.

**A** — Yes.

**Q** — When did the current G.I. educational bill take effect?

**A** — While the present G.I. Bill became law in June 1966, it covers veterans who served after January 31, 1955.

**Q** — I am a 19-year-old college student who draws a death pension from VA. When I marry will my pension be discontinued?

**A** — Yes. Pension is not paid to a child after marriage.

**Q** — A service-connected injury left me permanently and totally disabled. Will my children receive VA educational assistance while in high school?

**A** — No. Under this program, the law prohibits payment for a regular high school education, unless the child has a mental or physical disability.

## McDANIEL AND BROWN WIVES PLAY THE LONG WAITING GAME

Mrs. Jean McDaniel exhibits a kind of faith that at times is even frightening to herself.

"I try to carry on," she said, "because I know I'm the only one who can take care of my children. I guess it's the faith my husband has in me to do what I have to do under the circumstances."

Attractive Mrs. McDaniel is one of three Greensboro wives, whose husbands are currently prisoners of war in Southeast Asia. She and her husband, Air Force Capt. Norman McDaniel, are A. and T. graduates.

Also playing the long waiting game is Mrs. Shirley C. Brown, currently enrolled at A. and T. Her husband, Air Force Capt.

Earl C. Brown has been reported missing in Laos.

Except for a taped message monitored and recorded from Radio Hanoi by a CBS newsmen last December, Mrs. McDaniel has not heard her husband's voice since July 20, 1966.

Her only other contact with him has been six or seven brief letters (usually five or six lines) which Hanoi has allowed him to write.

But Mrs. McDaniel's animated conversation belies her unfortunate circumstances.

"I guess I really don't know what kind of power I have been going on," she said with a smile. "After a while, it's all kind of vague."
