Changing times and new pri-orities require the rearrangement of government programs to meet present needs. The White House has proposed a number of major . 130.82 changes in the organization and structure of Federal activities. Last week, the first of these reor-ganization plans was given final consideration and approval by the House of Representatives.

13.63 Under the terms of the President's executive reorganization authority, the Congress has 60 days from the date of the submission of a plan to consider and work its will on a measure of this kind. In a sense, this is a Congressional veto process in which the Congress may disapprove any such action by the President and demand that the plan be cancelled. If the Congress fails to act, the plan becomes operative. 


