

Citizens are invited to submit proposals on how the city should spend community development funds, over a period of four years. The city is entitled to \$4,160,000. in community development block grants from the U.S. Department of block grants from the U. S. Department of Housing and Urban Development. During the upcoming program year the city will receive \$1,040,000 in C. D. Funds. The city is

now developing its community development program and needs YOUR input. This is your chance to become involved.
