## **Foote Has** Increased Earnings

Foote Mineral Company reported net earnings of \$648,000, equal to 6c per share, for the second quarter of 1977 compared with \$1,489,000, or 17 cents per share for the same period of 1976. Sales were \$33,575,000 compared with \$80,028,000 in the 1976 quarter.

Six months net earnings in 1977 were \$2,068,000, or 22 cents per common share after ayment of preferred indidend, compared with \$3,603,000, or 43 cents per common share in the same period of 1976. Sales were \$66,592,000 compared to \$60,213,000 for the same period of 1976.

W. T. Barrett, president and chief executive officer, said that lower earnings were principally a result of continued increased operating costs without equivalent price increases for ferroalloys. 




