Rev. John Gaston of East Spencer, N. C., will preach each night at 7 p. m.





Rent Program Response Is Small

has been misunderstood about the program is that many landlords have gotten the idea that HUD is going to force this program on them.

"It's not compulsory," he said. "Landlords and tenants can participate as they see fit. If he participates, his house must meet minimum standards. 'Most homes would meet minimum standards without the landlord spending a cent.'"

A sample chart distributed by Honeycutt noted that a low income family of four in Cleveland County would have an income of \$9,900 a year. A very low income for a family of four would be \$6,200.

Another chart showed that the maximum allowable rent under this program for a three-bedroom home in Cleveland County would be \$98 per month.

Honeycutt pointed out that the rent schedules are automatically examined each year and that in the past rents have been increased approximately 10 percent a year. However, the only promise made by HUD is that the schedules will be examined each year.

Over a five-year period, Honeycutt said, the program would mean about \$200,000 for the Kings Mountain economy. He estimated there would be 40 housing units participating in Kings Mountain.

"This has been a very fast moving program in North Carolina," he said. "We first

heard of this in January and in February less than 40 counties were involved. Now there are 75 to 80 involved.

"Usually in programs like this," he said, "there's a local match or something that has a catch to it. But, in this, if you want to participate, you do, and if you don't, you don't."

Honeycutt said his office will continue to search out interested tenants and landlords, despite the small turnout at Tuesday's meeting, and he said that after signing of contracts, it would take only 30 to 40 days to begin dispersing money.

Jones Rezoning Request Denied By Commissioners

Several public hearings were held Monday on rezoning matters, but the only one to draw any comment from the audience concerned Dr. Craig Jones proposed in and Out Store.

The property is on the corner of W. King and Juniper Sts. Dr. Jones, of 210 Groves St., Shelby, requested the two lots be rezoned from R-0 (Residential Office) to NB (Neighborhood Business).

Scott Cloninger, a Kings Mountain attorney and one of the resi-

dents in the area where Dr. Jones' lots are located, said he had been elected spokesman for the group opposing the rezoning. The group included residents, First Baptist Church, Boyce Memorial ARP Church and Kings Mountain Hospital.

Cloninger said the increased traffic flow would be a detriment to the area, especially the hospital, and that a business such as the one Jones proposes would not be in keeping with the growth of the area.

The Zoning and Planning Board had recommended the rezoning request be denied and that was the action taken by the commissioners.

Another rezoning request was tabled for further study by the commissioners.

This one was submitted by Paul R. Sheffield to rezone from R-8 to general business property on E. King St. at Kings Mountain Motor Court.

Sheffield wanted the change for future growth and additions and to locate a UFO research station there.

Commissioner Norman King had the action tabled in order to find out what a UFO station is and what it would mean.

However, Tuesday Sheffield said the UFO research center idea had been dropped. He said the UFO center was

the idea of James Caldwell of Grover originally.

Sheffield said he still wants his property rezoned for future growth and additions.

In other business, the board approved a rezoning request from Mrs. Elizabeth Lynch. She asked that her property off S. Cherokee, one lot over from the new city hall site, be rezoned from R-8 to Commercial Business.

Approved for forwarding to the Z&P Board a request from Otha and Betty Campbell to rezone 902 Second St. from R-8 to General Business to locate a "small store" on the property.

Approved a request from the Kings Mountain area 4-H Clubs to erect 4-H symbols at the entrance

to the city. Received bids on a backhoe for the Public Works Department from Case Power and Equipment Co., Charlotte for \$18,763.25 and from Wooten Equipment Co., Newton for \$18,300. Award will be made later.

Approved an informal bid of \$3,998 from Neal Hawkins Co., Gastonia, for paving Ark St. from Margrace Rd. to Fulton Dr. to complete a housing project.

Agreed to enter into contract with the N. C. Department of Transportation for installation of safety signals at the Hawthorne Rd. and Oak St. railroad crossings. This is part of a continuing program the city has with DOT to upgrade safety precautions at railroad crossings in the city.
