Hambright Re-elected To Third Term

Postmaster Fain Hambright of Grover was elected to his third term as National Vice President of the National League of Postmasters at the 74th annual League convention held in San Juan, P. R. during the week of August 21-26.

Hambright, postmaster at Grover for 17 years, was elected on the first ballot as 14 Postmasters vied for the nine seats on the National Executive Board of the League, the oldest Postmasters' organization in existence; founded in 1904.

Statewide president of the State League of Postmasters 1962-64, Hambright has served as Southern Region League of certificate of appreciation from the Southern Regional

Postmaster General in June 1975. He also received the National Postmaster of the Year Award in 1978.

Hambright's father, R. E. Hambright, Sr. was the first rural mail carrier in Grover beginning in the early 1900's.


Hambright is also serving as national advisor to the five Regional Deputy Directors. He served as National Convention Chairman in Hollywood, FL in 1974; Phoenix, Arizona in 1976 and this year in San Juan, P. R.

Who Will Run For Office?



GROVER - Who will run for mayor and council here this election year?

Mayor Bill McCarter said he definitely is not a candidate and Councilmen Dean Westmoreland, Tommy Keeter and Martha Byars have not decided as yet what they plan to do.

A teacher's aide at Grover Elementary School, Mrs. Byars said, "I have been considering running again, but I haven't decided for sure. My two years on the board have been enlightening to say the least. It hasn't really been a bad experience."

Mrs. Byars, who is married to Gary Byars and is the mother of one daughter, was one of seven candidates in the race two years

Tommy Keeter, who is owns and operates Keeter Furniture. was also one of the winning three councilmen two years ago.

"I haven't ruled out running for re-election," Keeter said,

"but I have to come to some real decisions as far as running my business before I can say for sure whether I'll be a candidate or not."

Keeter said he didn't realize, even for a town the size of Grover, that so much time would be demanded of elected officials. 'That's tough on you especially if you have a business to run."

Dean Westmoreland, who was appointed to complete Bobby Hambright's unexpired term in September 1976, has two decisions to make. "I don't know about running for office. But once I decided that, then I'll have to decide whether to run for the board of for mayor. Several people have talked to me about seeking the mayor's office instead of the council.

"I will have to admit," Westmoreland said, "That even the short time I have served on the board that it has been a rather rewarding experience." Mayor McCarter announced

earlier that he will not seek reelection because he feels he doesn't have enough time to devote to local government.

"I've been in local government for 20 years," he said. "Eighteen on the board and the past two as mayor. The job needs someone who can do it justice. There are lots of good people in Grover who are qualified," McCarter said.

Grover voters will elect a mayor and three councilmen in the Tues., Nov. 8 municipal election. Operated under a Non-Partisan Plurality type procedure, candidate filing will begin at noon Fri., Sept. 16 and close at noon Fri., Oct. 7. Voter registration for the November 8 election will close on October 10.

Clyde Randall, chairman of the Grover Elections Board, said the filing fee for mayoral and council candidzates is \$5. Candidates will file with board secretary Mrs. Leary White.

Sylvia (Mrs. Ray) Holmes of Kings Mountain and Sarah Falls Elliott of Shelby, formerly of Kings Mountain, are day class instructors on the Cleveland Tech campus on Mondays, Tuesdays, Wednesdays and Thursdays from 8 a. m. until 2:15 p. m. for 11 weeks beginning Thurs., Sept. 29. Minimum cost is a \$5 tuition fee per quarter and covers all subjects. Textbook cost is around \$10 per quarter for four subject course load.

Mrs. Holmes says the advantage of the classes is that it's helpful to those who are out of the habit of studying and offers interaction with classmates. There are no exams, a passing grade is required in necessary subjects. Courses are tailored to suit the pupil's needs.

Four day classes are offered daily, starting at 8 a. m., 9:30 a. m., 11 a. m. and 1 p. m. on the Tech campus. Students may attend one, two, three or all four classes, gaining credit ac-

graduate a student needs four English, two Math, two Science, two Social Studies and six elewctives which can include typing and other approved Tech courses.

Mrs. Holmes teaches two math classes ranging from basic arithmetic to the metric system and algebrae One. All students work individually at their own rate in the math classes. She also teaches two Science classes. Meanwhile, Mrs. Elliott

teaches two English classes, a history class, and a class of either Sociology or Psychology. The timetable of the classes is determined each quarter by the needs of the students scheduling preferences being given to those due to graduate at the quarter's end. The oldest pupil to date was 71
