WHERE ARE PUMPS? — Otis Falls poses in the bay at his W. King St. Exxon Station where three gasoline pumps were completely destroyed Saturday as a side-effect of a two

car wreck at the King and Battleground intersection. It happened after the station was closed.

Eleven People Injured

Eleven people were hurt, three gasoline pumps were demolished and two cars were heavily damaged in a two-car crash Saturday night on King St. at the overhead bridge. City Ptl. B. G. Benton said the accident occurred when a 1969 Chevy operated by Geraldine Roberts made a left turn into the path of a 1970 Mercury operated by Pat Caveny.

Benton said the accelerator of the Mercury became stuck due to the impact and pushed both vehicles into the service lot of Otis Falls Exxon, crashing into all three gas pumps on the North side of the lot and demolishing them. The seven occupants of the Roberts vehicle and the four occupants of the Caveny car were all taken to Kings Mountain Hospital for

treatment of injuries and released. Property damages included \$2500 to the gas pumps, owned by Otis Falls, \$950 to Ms. Roberts car and \$1600 to Ms. Caveny's vehicle. The accident occurred at 9:10 p. m. There were no other cars involved.

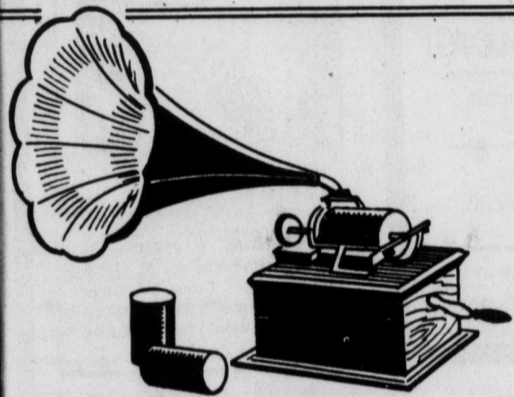
