Dr. Eskridge will handle clinics at Bethware School from 3-3:30 p. m.; Grover School, 3:45-4:15 p. m.; and West Elementary, 4:30-5 p. m.

The county health department's annual rabies clinics began yesterday and continue through Apr. 22. During the first week the clinics are held in every township and for the second week in the participating veterinarians' offices.
