*Heard the May police report from Chief Mike Brown.

*Following a 35-minute executive session, approved the termination of Patrolman Derek Johnson and eliminated the Reserve Police Officer's position. Both actions become effective immediately.

*Discussed purchase of a piece of property adjacent to Town Hall with Howard Jones, Personnel Manager of Minette Mills, and Realtor Marlene Peeler. A house and lot adjacent to Town Hall has been offered

YARD SALE

Kings Mountain Fire Department is planning a yard sale to raise money to purchase doors, windows and a ceiling for the Fire Museum. Anyone with items to donate may take them by the fire station or call 739-2552 and a fireman will pick them up.

SALE

Chestnut Ridge Volunteer Fire Department Ladies Auxiliary will sponsor a yard sale, bake sale and hamburger and hot dog sale Saturday from 8 a.m. until 4 p.m. at the fire department. All proceeds will go toward the purchase of new equipment and construction

for sale for \$8,100 and a 2,900 square feet warehouse across the street from Town Hall is for sale for \$17,400. The town will be given first choice on both pieces of property.

*Renewed the town's garbage contract for 1982-83 at the same rate as 1981-82.

*Discussed building wheelchair ramps on each side of Linden Street near First Baptist Church, and extending a sidewalk 408 feet down Highway 226. The board agreed to seek right-of-ways before adopting the project.

*Discussed, but took no action, on purchasing fire-proof file cabinets for Town Hall.

*Approved budget transfers of \$2,525.53 from Town Maintenance and \$357.92 from Elections to Streets; and \$726.30 from Legal Services to Sidewalks. McCarter said the action would make the Street budget be overspent by only \$3.23 and would balance the Sidewalks budget.

*Appointed Grady Ross to serve the unexpired term of Commissioner Vickie Smith, who resigned recently. Ross, who ran sixth in the voting for five commissioner seats in the last election, will be sworn into office at the next board meeting.
