Construction Underway On Christ The King Church

The members of Christ the King Catholic Church in Kings Mountain extends an invitation to all past, present and future parishioners and friends to stop by and visit their building site at 714 Stone Street near the recreation center. Construction is well underway for their new worship facility. The main sanctuary will have initial seating for 150 people with room for expansion without further construction. The basement area will house classrooms and a kitchen and dining/all purpose room.

A building fund drive is under-

way in the parish. Pledges have been made by parishioners and friends and collections are on schedule. The project financing is being assisted by funds from the National Catholic Extension Society and the Diocese of Charlotte. The total projected cost, with interior furnishing and unfinished basement, is expected to be in the neighborhood of \$170,000. Carolina Artisans of Shelby, is in charge of construction. The architectural work was done by Crawford Murphy of Architectural Design Group of Shelby.

The parish of Christ the King was established in 1960. Since that time, worship services, educational classes and fellowship activities have been held in a variety of temporary "homes", including the American Legion building, an old Presbyterian church in town and Trinity Episcopal Church. Until the building project is completed, which is scheduled from some time in May, all Masses and CCD classes are being held at Resurrection Lutheran
